Next, it considers trends in regional output and employment to identify which sectors contribute most to the area's economy as well as the role and importance of tourism in the economy of Stellenbosch.

The last section covers the implementation plan which covers the integration of various long-term strategies of the municipality such, but not limited to:

- Competitive Strategies
- Infrastructure Strategies
- Inclusion Strategies
- Trade Promotion and Sector Development Strategies
- Sustainable Growth Strategies
- Tourism Development and Resilience Strategy


